A RETURNING MEMBER, whether your membership was last year or five years ago, must pay a full \$60 for annual membership, *no matter when you join*. If you have any questions about this, please speak to our president, Dave Salisch or membership Dee Middleton or Chris Bykowitz.

A NEW MEMBER is someone who has never been a member of the ski club at all. Only new members are entitled to a prorated annual dues (\$5/mo) starting from any month that they join through the following May.

A VISITOR is someone who has never been a member of our ski club and is attending a monthly meeting or a ski club event for the first time. A visitor is welcome to attend one function at no cost. That same visitor is welcome to attend the next two and three functions, for a cost of \$5.00 each, as a contribution toward food costs. A visitor may not attend more than three meetings without joining & paying a prorated annual dues (\$5.00 for each remaining month until the following May).
